A. Description of original monument and accessories and/or subsequent restoration: Original Government Survey by Clark, 1823: 10" W. Oak N. 33° E. 7 lks.; 13" W. Oak N. 55° W. 26 lks.



B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:

I found a R.R. spike at road surface agreeing with remaining references.

Four of the LCRC witnesses remained.



C. Description of monument for corner and accessories established to perpetuate locating the position of the corner: Replaced R.R. spike with Hillsdale County Remonumentation bar with cap in a monument box and is accepted as the best available evidence of the position of the original corner.

In centerline E/W road. East 48.86' R.R. spike C-1, T7S-R3W. N.E. corner S. post of church sign N. 41° W. 52.75'. Found P.K. E. side power pole N. 27° E. 24.80'. Cor. church foundation S. 13° W. 46.20'. Set nail & spotter N.W. side 40" Oak S. 40° W. 34.52'.
