J-3: FOUND 3/4" PIPE IN MONUMENT BOX 1 FOOT SOUTH CENTERLINE OF ROAD EAST-WEST AND 5.5 FEET WEST CENTERLINE ROAD TO SOUTH, FITS FENCE TO THE NORTH. I-3 TO J-3 AND K-3 IS ON LINE WITH EACH OTHER AND IS ABOUT 3 FEET FROM A SPLIT. NO OTHER WITNESSES FOUND. ACCEPTED AS THE BEST AVAILABLE EVIDENCE OF THE POSITION OF THE CORNER.

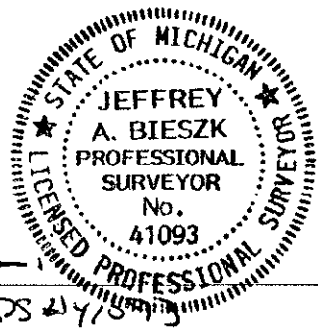
