

FOUND CONCRETE MON. WITH CAP #18998 IN CONCRETE COLLAR . 4" BELOW ASPHALT SURFACE AND 0.5'± NORTH OF THE C/L OF COVERT ROAD. FOUND THE TWIN POPLAR, THE MICH. BELL RISER AND THE POWER POLE AS DESCRIBED BY LESTER IN (4-A) ABOVE. A SEARCH OF THE INGHAM COUNTY DRAIN COMMISSION RECORDS DID NOT GLEAN ANY SUBSEQUENT INFORMATION ON THE LOCATION OF THIS CORNER. ACCEPTED THE LOCATION OF THE CONCRETE MONUMENT PER THE 1947 MANUAL OF INSTRUCTIONS FOR RE-ESTABLISHING A LOST CORNER.
