FOUND ONLY REMAINING WITNESS FROM 1959 ROAD COMMISSION WITNESSES. FOUND BOATSPIKE IN REMAINS OF 20" STUMP. S 18° 43' E, 80.90'.

ORIGIN OF 1/2" IRON RE-BAR IS UNKNOWN, HOWEVER IT OCCUPIES LOCATION OF PREVIOUSLY WITNESSED BOATSPIKE.

FOUND 1/2" IRON IN MONUMENT BOX IN THE CENERLINE OF M-36 AND MERIDIAN ROAD, AND IS ACCEPTED AS THE BEST AVAILABLE EVIDENCE OF THE POSITION OF THE ORIGINAL CORNER IN POSITION OF BOATSPIKE. FOUND BOATSPIKE WITNESS FROM 1959, ROAD COMMISSION, AT SOUTH, 18°43' EAST, 80.90. 1/2" IRON OCCUPIES SAME POSITION AS BOATSPIKE REFERRED TO IN 1959.
