 - 1). A SURVEY WAS RECORDED BY A. JACKSON, COUNTY SURVEYOR, VOL. 2, PAGE 98, (DATE UNKNOWN, CIRCA 1848). HE DID NOT DESCRIBE THE CORNER AND WITNESSED A 10" WHITE OAK, S29-1/2 E, 7-1/2 LINKS.

- B. Description of corner evidence found and/or method applied in restoring or reestablishing corner: FOUND THE CORNER SET BY WILLIAMS ALONG WITH (2) OF (3) BEARING TREES. NOT ONLY WAS WILLIAMS CORNER IMPROPERLY SET, ITS POSITION WAS NOT IN ACCORD WITH WHAT HE STATED. EXCAVATED AND FOUND A 12" X 3/4" IRON PIPE (2' DEEP) BENT AND IN A HORIZONTAL POSITION ABOUT 12 FEET WEST AND 5 FEET SOUTH OF THE WILLIAMS CORNER. IT APPEARED THAT THE PIPE WAS INTENDED TO OCCUPY THE INTERSECTION OF THE 1/4 LINES AND WAS POSSIBLY DISTURBED DURING EXCAVATION AND CLEAN OUT OF THE BASH-FORD COUNTY DRAIN, LYING \pm 25' NORTH. DID NOT FIND ANY EVIDENCE SUPPORTING THE POSITION OF WILLIAMS CORNER OR ANY RECORDS, PRIVATE OR PUBLIC SUPPORTING EITHER POSITION. BROUGHT THE PIPE TO SURFACE AND SET IT ON THE NORTH-SOUTH AND THE EAST-WEST 1/4 LINES. THIS POSITION IS 1.0 FEET ± NORTH OF WHERE IT WAS ORIGINALLY LYING. JACKSONS MEASUREMENT FROM HIS SURVEY WAS RECORDED AT 156 RODS, 30 LINKS (2593.8') TO THE WEST 1/4 CORNER FROM THE CENTER OF SECTION. MEASURED 2605.12 FEET. SET CAP EMBOSSED P. A. 345, P. S.
