- An Act 132 survey recorded in Liber 2, Page 686 by Richard Steadman, P.S. #11370 on April 14, 1976 states "3/4" pipe in monument box; Twin 14" Walnut SW 66.19'; 7" Hickory WNW 45.67'.
- An Act 132 survey recorded in Liber 4, Page 1278 by Hathaway J. Haynes, P.S. #5260 on July 29, 1986 states "3/4" pipe in monument box" gives no description of witnesses.
