- A. Description of original monument and accessories and/or subsequent restoration:
- Original corner set by Musgrove Evans D.S. on December 21, 1826 at 1. a distance of 73.97 chains (4882.02') from C-3 and 208 links (137.28') West of C-13, Meridian Twp. "Int. N. Boundary 208 I. W. of Post. Set post cor. Secs 5 & 6 fw. Beech 8 S 3 W 12. Beech 18 S 36 E 52."

- 2. Book 3, Page 15 of County Surveyor's Records shows a survey by T.J. Brown D.C.S. on September 28, 1870 in which he set a stone for the corner. Corner measured 40.00 chains (2640.00') from B-1 and 39.74 chains (2622.84') from C-2. No witnesses given.
- An Act 132 survey recorded in Liber 1, Page 252 by Ronnie M. Lester R.L.S. #18998 on May 3, 1972 3. describes corner as a found boatspike measuring 2636.77' from D-1 and 2241.92' from C-2. B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:

Found 3/4" iron in Monument Box in the centerline of Jolly Road and on the approximate centerline of Hagadorn Rd. projected from the South. Found Witnesses: Nail and Tag #16053 NW side Utility Pole S 45° W, not measurable due to placement of a new pole in between it and the corner. Nail and Tag #25832 E. side Utility Pole S 10° W 70.94'. Nail and Tag #16053 NE side Guy Pole S 60° E 129.14'. Nail and Tag #16053 E. side Guy Pole N 70° E not measurable, tag being opposite corner. Standard concrete monument #18998 in monument box, C-13, Meridian Twp., East 145.22'. Corner measured 2636.40' to D-1. Corner in an area where Jolly Rd. has been rebuilt many times, therefore original corner and stone assumed to be obliterated. Accepted 3/4" iron as best perpetuated location for the corner as used by many area surveyors. Affixed a 2 ½" diameter aluminum P.A. 345 cap #28414 to the 3/4" iron.
