- A. Description of original monument and accessories and/or subsequent restoration:
- Corner not set in Original Government Survey.
- 2 Book 3, Page 352 of the County Surveyor's Records show a survey by A. Jackson C.S. on April 27, 1854 in which the corner measured 143 rods, 20 links (2372.70') from J-1, and 158 rods, 36 links (2630.76') from J-3.
- An Act 132 survey recorded in Liber 3, Page 914 by Larry A. Bryan L.S. #25832 on June 26, 1979 identifies corner as a Found Boat Spike at fence intersection measuring 2650.88' from J-3 and 2643.51 from I-2. Witnesses: M.D.S.H. Tag South side 10" Wild Cherry West 5.26'. Set Nail and Tag North side 16" Maple S 60° E 32.96'. Set Nail and Tag West side 8" Ash S 10° E 8.90'.
- A L.C. R.C. recorded in Liber 5, Page 264 by Larry A. Bryan L.S. #25832 on July 19, 1979 states of the corner, "Found large rusted boat spike in base of decayed anchor post at the intersection of old fencelines to East, West, and North in swampy area in close accord with (witnesses in A-3). Measured South to 1/8 Corner 1325.44' in close accord with M.D.S.H. records and a survey by A. Jackson dated April, 1854. (V.2., P197) of the County Survey Records. Accepted Boatspike as corner identified by M.D.S.H. records as interior 1/4 of Section."

B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:

Found a Boatspike in swampy area. Found minute traces of fence North, East, and West. Found Nail and Tag #25832 South side Multi 10"-14" Maple East 36.23'. Found Nail and Tag #25832 North side 24" Maple S 60° E 32.97'. Fd. Nail and Tag #25832 West side 11" Ash S 10° E 8.94'. Accepted the Boatspike as the best perpetuated location for the corner based on its being at an old fence intersection and having record of it being used in a County Survey (A-2). Replaced Boatspike with a 3/4" x 24" iron form pin and a 2 1/2" diameter aluminum P.A. 345 Cap #28414.

Description of monument for corner and accessories established to perpetuate locating the position of the corner;

A 3/4" x 24" iron form pin with a 2 1/2" diameter Aluminum Cap #28414, witnessed by: Found Nail and Tag #25832 South side Multi 10"-14" Maple East 36.23' Found Nail and Tag #25832 North side 24" maple S 60° E 32.97" Found Nail and Tag #25832 West side 11" Ash S 10° E 8.94' Set Nail and Tag #28414 SE side 28" Cherry West 41.29
