- A. Description of original monument and accessories and/or subsequent restoration:
- 1. The original corner was set by Musgrove Evans, U.S. Deputy Surveyor on Monday, Feb. 5, 1827 as noted on Page 78 of the GLO field notes for Meridian Township. "Set post cor. to Sect. 5,6,7&,8,; witnessed by: Elm 20 S46W 33; Lynn 26 N80E 21.
- 2. Anson Jackson, County Surveyor used corner in a May 9, 1848 survey as recorded in Liber 1, Page 231, County Surveyors Records. No material was given and one witness as: Sugar 26 N73 1/2E 26.
- 3. Anson Jackson, County Surveyor used corner in a May 11, 1848 survey as recorded in Liber 1, Page 232, County Surveyors Records. No material was given and it was witnessed by: Sugar 26 N73 1/E 26; W. Oak 36 S20E 30.
- 4. Anson Jackson, County Surveyor used corner in a May 12, 1848 survey as recorded in Liber 1, Page 233, County Surveyors Records. No material was given and it was witnessed by: Elm 20 S48 1/2 W 28; Sugar 26 N73 1/2E 26.

B. Description of corner evidence found and/or method applied in restoring or reestablishing corner: Found a broken off railroad spike in the centerline of Hagadorn Road and Lake Lansing Road. Excavated area to a depth of 2.5 feet and found a bent 1" pinch pipe. Excavated to base of pipe and found that pipe was set next to a 1"x4" wood stake and a 1"x1" wood stake. Base of pipe falls 0.02' south and 0.11' East of location of railroad spike. Accepted base of pipe as location of pipe as noted in A-10 and replaced pipe and railroad spike with a 3/4" x 56" iron rod with cap stamped "PA 345 PS 28414" in a monument box. This surveyor accepted the position of the pipe as the best perpetuated location of the corner position.

C. Description of monument for corner and accessories established to perpetuate locating the position of the corner;




