B. Description of comer evidence found and/or method applied in restoring or reestablishing corner:
Found 1" Bar in monument box 2' west of centerline of Hagadorn Road and 23.8' South of centerline of westbund M-78. Excavated below bar and found no further evidence. Replaced 1" bar with standard 3/4"x24" smooth iron rod with cap stamped "PA 345 PS 28414". This surveyor accepted the location of the 1" iron bar as the perpetuated location of this corner based on the history of the bar.
