2) P.A. 132 SURVEY RECORDED IN LIBER 7, PAGE 616, DATED JAN. 31, 1995, BY M. MAHIEU, P.S. 28414, IDENTIFIES THIS CORNER AS A 1/2" IRON W/CAP. WITNESSED AS: N&T, S. SIDE 18" MAPLE, EAST, 9.35'

N&T, S. SIDE 8" OAK, N80°W, 12.83" N&T, N. SIDE 16" MAPLE, 15.74' N&T, W. SIDE 14" MAPLE, 6.11"

CHISELED OUT THE ABOVE TAGS AND FOUND THEM TO BE NO. 17640 (G. YOUNG). THEY APPEAR TO HAVE BEEN SET AROUND 20 YEARS AGO BY THE DEPTH OF THE BARK.

DID NOT FIND ANY SUBSEQUENT P.A. 132 SURVEYS OR P.A. 74, L.C.R.C. FOR THIS CORNER.

Description of corner evidence found and/or method applied in restoring or reestablishing corner:

MET WITH AND TO TALKED TO A MR. MORRIS LOTT, OWNER OF THE PROPERTY DIRECTLY SOUTH OF THE CORNER, HE POINTED OUT THE 1/2" IRON BAR WITH M. MAHIEU'S CAP NO. 28414 LOCATED AT THE INTERSECTION OF AN EAST-WEST BARBED WIRE FENCE AND WITH FENCE REMNANTS TO THE NORTH. MR. LOTT POINTED OUT THE AREA OF SOME FIELD STONES AND MENTIONED THAT WAS THE AREA OF WHERE AN ANCHOR POST WAS WHEN HE BOUGHT THE PROPERTY OVER 50 YEARS AGO.. EXCAVATED DOWN THROUGH A CIRCLE OF STONES AND FOUND THE ROTTED REMAINS OF A WOOD POST NEXT TO AN OLD PLOW POINT, DATED AND IDENTIFIED AS MOORE, 9-5-1899. MR. LOTT IDENTIFIED THE PLOW AS A HORSE DRAWN AND WAS AMAZED THAT THE DATE AS STAMPED WAS STILL LEGIBLE. MR. LOTT IS A COLLECTOR OF PLOW POINTS AND READILY ACCEPTED THE POINT AS OFFERED TO HIM, SINCE THERE WAS NO DOUBT IN MY MIND THAT IT REPRESENTED THE POSITION OF THE McCREAY CORNER SET IN 1890. CORNER IS LOCATED 6 FEET SOUTH AND 2.5 WEST MORE OR LESS FROM THE CORNER IDENTIFIED BY 2-A ABOVE. SET A 3/4" X 24" FORM PIN AND 2.5" ALUMINUM CAP STAMPED P.A. 345, P.S. NO. 18994 IN THE POSITION OF THE PLOW POINT.
