THIS CORNER WAS FIRST ESTABLISHED BY U.S. DEPUTY SURVEYOR JOHN MULLETT IN 1831. A WOOD POST WAS SET WITNESSED BY A: 11" SUGAR N 38° E 20 LINKS AND A 18" SUGAR WEST 6 LINKS. THERE IS NO RECORDED COUNTY SURVEY INFORMATION FOR K-7.

THE IONIA COUNTY ROAD COMMISSION PAVED PECK LAKE ROAD IN 1962. THE ROAD COMMISSION FOUND LARGE STONES AND RAISED IT WITH A BOAT SPIKE AND NAIL AND WASHER, AND TOOK 5 WITNESSES.

PROFESSIONAL SURVEYOR RON HELSEL NO. 18994 RECORDED K-7, JANUARY 1974, RECORDED IN LIBER 1 PAGE 95. HELSEL FOUND THE NAIL AND WASHER AS CALLED FOR BY THE ROAD COMMISSION.

B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:

FOUND A RAILROAD SPIKE UNDER THE BITUMINOUS ROAD SURFACE. BELOW RAILROAD SPIKE FOUND A 1" BOAT SPIKE, BELOW BOAT SPIKE FOUND A STONE PILE WITH LARGE STONES. ACCEPTED THIS MONUMENTATION AS THE PERPETUATION OF THE POSITION OF THE ORIGINAL CORNER.
