Description of original monument and accessories and/or subsequent restoration: Corner I7 (Section Corner 14, 15, 22, & 23, T43N, R33W): Corner J7 (1/4 corner between Sections 14 & 23, T43N, R33W): Corner K7 (Section Corner 13, 14, 23, & 24, T43N, R33W): These corners all occur in county road r/w, and any original evidence has long since been obliterated by road construction. See B, below, for monuments found in place, representing the described corners. Note: Only what was found is being reported here; if these are legal corners it is probably only by common report, as the original field note measurements do not support them. B. Description of corner evidence found and/or method applied in restoring or re-establishing corner: Corner I7: On 9/15/76, witnessed an unknown length of what appears to be spring leaf, found buried in approx. CL of E-W road at approx. intersection with CL of a woods lane going S (may have once been a township road). Corner J7: On 8/23/73, witnessed an unknown length of 1" I.D. iron pipe found in approx. construction CL's of intersecting county roads. This pipe bears N89056.4'E 38.862 ch. from the monument at I7, and S89°32.0'W 40.551 ch. from the monument at K7, the record distances being 40.20ch., respectively. Corner K7: On 9/15/76, witnessed an unknown length of narrow-gauge railroad track found in place at a right-angled bend in county road. Fence lines to N & £ appear to originate from this point. C. Description of monument for corner and accessories established to perpetuate locating the position of the corner:

Corner 17: Iron spring leaf, length unknown, buried vertically in road.
