A. Description of original monument and accessories and/or subsequent restoration:

B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:

No evidence of original corner or bearing tree remains. Corner position found marked by a pointed Railroad Rail. | Corner position has been used and accepted as the corner locally, for many years. Set an aluminum pipe monument at the corner position and reset Railroad Rail next to monument as described below. Monument located on East side of Helgemo County Road and along edge of tree line. Monument is 3" above ground surface.

This corner is accepted as the best available evidence of the position of the original corner.

C. Description of monument for corner and accessories established to perpetuate locating the position of the corner:

At the corner position, I set a 2" diameter by 30" long split base aluminum pipe monument with a 3" cast aluminum cap, stamped to read: Iron County Remonumentation, T43N, R34W, S-22, S-23, S-27, S-26, 1993, R.L.S. 27457; from which I established the following new blazed and scribed bearing trees: (all measurements taken to a nail
