- A. Description of original monument and accessories and/or subsequent restoration:
- (A9) Corner common to Sections 19-30 T44N-R31W and Sections 24-25 T44N-R32W. 2002 Corner approved by Iron Co. Peer Group and recorded in Liber 9 LCR Page 317 by G.L.Pisoni PS. Found Wisconsin Michigan Power Company concrete monument with 3" square brass tablet. White Pine 18" S49E 95.89' White Pine 36" N61E 91.26', White Pine 22" N80W 101.61', Aspen 6" S39W 9.11', Steel sign post North 0.80'.
- (A7) Corner common to Sections 18-19 T44N-R31W and Sections 13-24 T44N-R32W. 2003 Corner monument approved by Iron Co. Peer Group and recorded in Liber 10 L.C.R. Page 147 by G.L.Pisoni PS. Found Wisconsin Michigan Power Company concrete monument with 3" square brass tablet. Cedar 12" N45E 26.73', Cedar 12" S20E 4.51', Cedar 12" S85W 13.82', B.Spruce 6" S69E 48.34', steel sign post N83W 0.80'.
