A. Description of original monument and accessories and/or subsequent restoration:

(5-Sec. 34) North 1/16 corner, Section 34. Not established in the original survey. Position for the corner established in 1962 by Herbert F. Larson RLS and shown, but not labelled, on the recorded Plat of Phelan, part of the SE1/4 of the NW1/4 of Section 24. No witnesses given.

(4-Sec. 34) Northwest 1/16 corner, Section 34. Not established in the original survey. Position for the corner established in 1962 by Herbert F. Larson RLS and described on the recorded Plat of Phelan, located in the SE1/4 of the NW1/4 of Section 24. The position is labelled "N.W. Corner of the SE-NW Section 34 T44N-R31W".

B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:

(5-Sec. 34) No monumentation was recovered at the corner position. Reestablished the corner in accordance with the Plat of Phelan, at the intersection of the platted centerline of Phelan Road to the south and the platted north line of Phelan Road to the west.

(4-Sec. 34) Found no monumentation at the corner position. Remonumented the corner position in accord with the Plat of Phelan, at the intersection of the North line of 66' wide Phelan Road and the West line of the plat. The position for the corner falls about 10' north of physical centerline of Phelan Rd (a dirt road at this location).

1.25" threaded rod in concrete cylinder (plat mon) S43E 93.4'
