B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:

(3-Sec. 32) Found the 1978 monument in good condition and at record bearing and distance from the remaining 1978 witness W.Pine 30" found in good condition. The Maple BT SW was not recovered. The monument is located substantially midway and on line between Section and Quarter corners and I accept same as a careful and faithful establishment of the position of the corner.
