A. Description of original monument and accessories and/or subsequent restoration:

(2-Sec. 35) East 1/16 corner common to Sections 26 and 35. Not established in the original survey. 1977 - A.O.Enger RLS monumented the corner at a position derived from his speculation as to the location of the Section line based upon observation of the location of natural features noted in the original notes. Set 1" I.D. x36" iron pipe with 3 3/4" alum. cap. Sugar Maple 6" S66W 28.8', Cedar 9" N32W 36.6'.

(5-Sec. 24) North 1/16 corner, Section 24. Not established in the original survey.

B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:

(2-Sec. 35) Recovered, but did not accept the 1977 monument as marking the proper position of the 1/16 corner. I reestablished the corner midway and on the Section line between Quarter corner 1310.95' west and Section corner 1310.95' east. From the position thus established, the 1977 monument bears approx. north, 36 feet distant. Removed the 1977 monument.

(5-Sec. 24) Established the corner midway and on a straight line between Center of Section 24 1318.98' to South and Quarter corner 1318.98' to North.

C. Description of monument for corner and accessories established to perpetuate locating the position of the corner:
