(8-Sec. 29) Established the corner midway and on a straight line between Quarter corner 1342.57' west and the intersection of 1/4 lines 1342.57' east.

(11-Sec. 29) Established the corner at the intersection of straight lines connecting opposite 1/16 corners. For 1/16 corner #15, Section 29, I did not accept the position of the 1974 monumented corner of record. Instead, I used a point located midway and on the Section line between Section corner C11 and Quarter corner D11.
