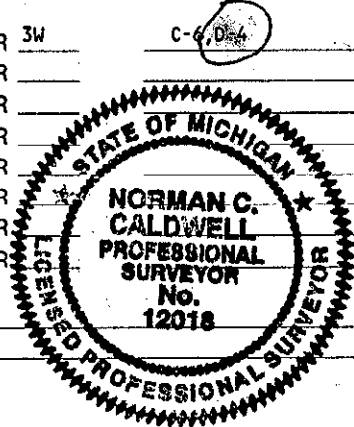

Found 10.4cm x 10.4cm Conc. Post w/ 16mm Iron Rod. (Origin Unknown)

C. Description of monument for corner and accessories established to perpetuate locating the position of the corner:

Fnd 13mm iron rod in Mon. Box per Bk.1 P.96, 169, 187, & 275; Bk. 2 P.508, 546 & 547; and Bk.3 P.858 and is accepted as the best available evidence of the position of the original corner.
