

Found pointed stone marked X and old buggy axel (lying down) at corner per C.S.R. notes. Found 30" pine stump (notched) N.54°E., 60.1' (C.S.R. N.54.5°E., 60.55') and remains of pine stump N.38°W., 69.9' (C.S.R. N.35.5°W., 69.3').

Found fence corner S.52°W., 52.7' with fence South, North, and West (appears to be West Right of Way fence). Section corner per Nowak survey is N.45°W., 56.4'. Nowak states he found an iron pipe.
