COMPUTED POSITION HALF WAY AND ON LINE BETWEEN THE TWO CORNERS. THOUGHT COMPUTED CORNER POSITION WAS LOCATED IN STANDING WATER OF MILL POND. SET 1" X 60" ALUMINUM PIPE MONUMENT FOR PA 345 REMONUMENTATION IN JACKSON COUNTY AS WITNESS CORNER 339.67 FEET EAST OF THE COMPUTED CORNER POSITION ON THE TOWNSHIP LINE. UPON SETTING MONUMENT IT WAS REALIZED THAT—THE ACTUAL CORNER COULD PROBABLY BE SET FROM OTHER SIDE OF MILL POND. EXTENDED EXISTING TRAVERSE AND ATTEMPTED TO FIND CORNER. POSITION FALLS IN VAST SWAMP
