In 1825, H. Parke - Deputy Surveyor, set a "Post" and recorded 2 witnesses: "Y. Oak 16, S10°E, 69 (45.54')" and "W. Oak 12, N24°W, 96 (63.36')".

Between 1886 and 1888, H.F. Bean reported "Witness standing found the remains of stake" and recorded 2 witnesses: "W. Oak 10, N37°E, 6 1/2 (4.29')" and "W. Oak 14, S22°E, 41 1/4 (27.22')".

Records of Consumer's Power Company (CPCo) dated 1959, note the corner as "Fire clay mon. to surface with 1/2" iron" and recorded 3 witnesses.

In 1972, Peter Kurzy - LS #5591, recorded the corner as "3/4" iron pipe" per Land Corner Recordation Certificate (LCRC) at Liber 1, Page 197.

In 1988, J. Maxson - LS #27454, recorded the corner as "Found 3/4" iron pipe as recorded in Liber 1, Page 197 of Corners, Jackson County Records" per LCRC at Liber 4, Page 125.

In 1990, J. Maxson - LS #27454, recorded the corner again as a "3/4" iron pipe in CL Road" per LCRC at Liber 4, Page 186. Witnesses on both of Maxson's LCRC's are identical and very close to Kurzy's.

Description of corner evidence found and/or method applied in restoring or reestablishing corner:

Found 24" Fire clay (F.C.) 0.2' below surface with a 3/4" x 17" iron pipe, 0.38' Northeasterty. Michigan Department of Transportation (MDOT) concrete right-of-way marker is 0.7'± Southerly. Also found a piece of crockery at bottom of F.C. Accepted F.C. as a careful and faithful perpetuation of the position of the original corner. Set a standard Jackson County Survey Monument (JCSM) in exact position of found F.C. Previously recorded LCRC's all appear to use iron pipe with witnesses to same iron pipe.

Description of monument for corner and accessories established to perpetuate locating the position of the corner.

Set 4" x 36" concrete monument with 1/2" x 36" rebar and Jackson County standard aluminum cap stamped "LS #29245, 1996, C-9, T2S-R1E". OF MICHIE
