Accepted FIRECLAY as a careful and faithful perpetuation of the position of the original corner as remonumented by H. F. Bean in 1886.

Set a Standard Jackson County Monument to replace the Fireclay and reset the bottom 13" of Fireclay, 4' below surface and below the monument. Set 2 broken pieces of fireclay on West and South side. Set stone around botton of fireclay and left old iron buried beside monument.
