J-2 Location of this corner falls in the Flat River.

The "Village of Lowell" (Liber 2, Pg. 55) covers most of this Section, with many lots and streets being perpendicular to the Flat River, without any reference to a N-S 1/4 line. The only reference to an E-W 1/4 line is from the West 1/4 corner East to the West 1/8 line (surveys in the W 1/2 of SW 1/4 refer to the NE corner of the W 1/2 of the SW 1/4 and the E-W 1/4 line).
