- Description of corner evidence found and/or method applied in restoring or reestablishing corner:
- Found iron per L.C.R.C. #908. This point checks Williams & Works survey records to 1914 and Exxel Engineering survey B-6 information. This iron was originally found by Williams & Works in 1914 and accepted as the Center Section for Canal Street survey. The North 1/4 corner falls on the North side of the Grand River and therefore does not control the E-W position of this corner. The iron is 48.7' West of a line between the N & S 1/4 corners of Section and 0.9' North of the E-W 1/4 line. Because of the long history of use of this iron accepted for the Center of Section.
