This corner was originally approved by the Kent County Remonumentation Peer Group and monumented by Williams & Works on 7/7/83 and was recorded per L.C.R.C. #3454.

Description of corner evidence found and/or method applied in restoring or reestablishing corner: B.

Found a Standard Kent County Monument 5' ± North of the C/L intersection of Alden Nash (bit.) running North and South and McPherson Street (gravel) running East and West per L.C.R.C.'s #3454 and #5790 as set by Williams & Works in place of a "T" iron they found over a 3/4" iron which checked L.C.R.C. #3292 and the K.C. Surveyor's records.
