Description of corner evidence found and/or method applied in restoring or reestablishing corner:

Found a Standard Kent County Monument 2.5' North of the C/L of Vergennes Street (bit.) running East and West per 1-11 L.C.R.C.'s #1952 and #8239 as set by Rob Jonker in place of a 3/4" round iron he found at grade inside of a 2"x30" pipe 16" below grade which checked L.C.R.C. #505 and the K.C. Surveyor's records.
