- В. Description of corner evidence found and/or method applied in restoring or reestablishing corner:
- Found a Standard Kent County Monument 5'  $\pm$  East of a tree row and fence line running North, on line of a tree row and J-7 fence line running East and West, per L.C.R.C.'s #3811 and #8244 as set by T. Chettleburgh in place of a 1" iron pipe he found which checked the 1903 survey by Williams & Works and K.C. Surveyor's records.
