A-4 Found a Standard Kent County Monument 6.0' West of the C/L of Ramsdell Drive (gravel) running North and South per L.C.R.C.'s #4305 and #6219 as set by Randy Kolehouse in place of a 1" bent iron he found which checked the notes of MSHD and Williams & Works and the K.C. Surveyor's records.

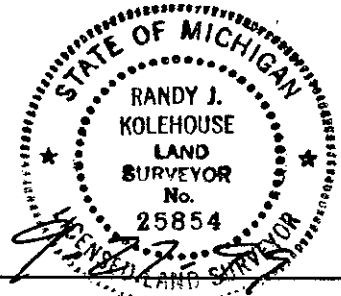
