B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:

H-1 Found a Standard Kent County Monument in a swamp (water 2' ± deep) 150' ± West of the C/L of Podunk Road (gravel) running North and South per L.C.R.C.'s #4003, #5071, and #9982 as set by John Bueche on the South line of Section 34 using government notes.

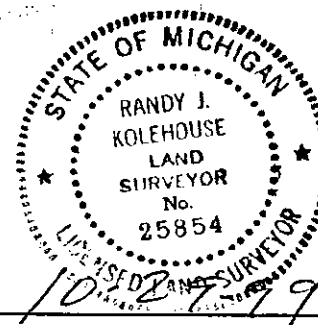
