This corner was originally approved by the Kent County Reimonumentation Peer Group and monumented by John Bueche on 5/22/89 and was recorded per L.C.R.C. #5160.

B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:

I-1 Found a Standard Kent County Monument 1' ± West of the C/L of Lincoln Lake Avenue (bit.) running North and South and 6' ± North of the C/L of 16 Mile Road (bit.) running East and West per L.C.R.C.'s #5160 and #9983 as set by John Bueche in place of a monument box he found which checked L.C.R.C. #1337 and the K.C. Surveyor's records.

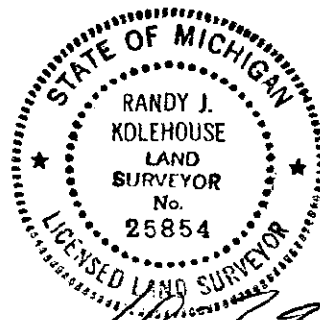
