

- B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:
- L-2 Found a 1" iron pipe per Kent County Witness Map (1938), Williams & Works Survey Records (1948-1969), Glaza Survey Records (1978) and Exxel Survey Records (1990) 20.0' West and 7.4' South of the intersection of 1/4 lines; also found iron set by All Points (1987) and used by Roosien (1990) at the approximate intersection of 1/4 lines. Due to the historical usage of the 1" iron pipe, it was decided to hold said iron as the Center of Section.

The selected location is accepted by me and is generally accepted by professional surveyors as the best available evidence of the position of the original corner.

- C. Description of monument for corner and accessories established to perpetuate locating the position of the corner:
- L-2 Replaced 1" Iron Pipe with a Standard Kent County Monument
