B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:

EXCAVATED THROUGH 3" OF BITUMINOUS ROADWAY AND A PREVIOUS SEAL-COAT SURFACE, AND THROUGH 3+/- FEET OF GRAVEL, 118.8 FEET WEST OF A FOUND IRON AT \$1/4 CORNER OF SEC 31, TIN R9W, AS INDICATED IN THE WILKINS & WHEATON SURVEY, FOUND NOTHING. IT APPEARS CERTAIN THAT THE TILE PLACED BY HODGEMAN WAS DESTROYED BY SEWER CONSTRUCTION. RESTORED POSITION OF IRON ON BASE LINE AT EAST SHORE OF GULL LAKE, BY BEARING AND DISTANCE FROM THE FOUND IRONS SHOWN AS BEING 33 FEET SOUTH OF BASE LINE ON THE WILKINS & WHEATON SURVEY, 1967, THEN PLACED THE HARRISON MONUMENT AND MONUMENT BOX ON RESTORED BASE LINE AND 118.80 FEET WEST OF STANDARD CORNER. ALL 3 WALNUT WITNESSES BY GOVE (BUDZIK) REMAIN, BUT NAILS ARE LONG GROWN OVER. CHECKED DISTANCE FROM CENTER OF ALL WALNUTS, IN EACH CASE THE DISTANCE FELL NEAR THE CENTER OF THE MONUMENT. ACCEPTED THIS AS BEST METHOD OF RESTORING THE POSITION OF THE TILE SET BY HODGEMAN, AND PERPETUATED BY WILKINS AND WHEATON, AND GOVE (BUDZIK).
