Original monument and accessories not recovered. No surface marker found. Found a 3/4 inch iron rod in a mon box below the surface of the asphalt. Surprisingly, this rod and box did not posses a magnetic field as our locator did not pick it up. Removed the rod and mon. box and found an earthen tile directly below rod position. Set steel sleeve over tile in mon box. Tile is 1.2 feet below surface of road.

C. Description of monument for corner and accessories established to perpetuate locating the position of the corner:

85, South Quarter Post Section 7, Town 2 South, Range 10 West, ratified by Kalamazoo County Remonumentation Peer Group on December 17, 1998. Location of earthen post is acepted as a careful and faithful perpetuation of the position of the original corner. Set steel sleeve in mon box over tile.
