1998 - Original monument and accessories not recovered. Found 1/2" dia. 24" long rod 3.5'+ below road surface. Fnd. clay tile directly below rod at depth of 5' + below road surface. Road to receive 3'+ more fill during 1998 reconstruction. Left tile in place

Note: Found 8"x8"x? Stone lying next to and southeast of tile.

C. Description of monument for corner and accessories established to perpetuate locating the position of the corner:

G-3, Northeast Corner Section 9, Town 2 South, Range 10 West, ratified by Kalamazoo County Remonumentation Peer Group on November 19, 1998. Position of the tile is accepted as a carefull and faithful perpetuation of the position of the original corner. Set 30" Harrison Monument in a Monument Box directly over tile.
