3. Description of corner evidence found and/or method applied in restoring or reestablishing corner:

Found a ½" diameter 18" long rebar in a monument box. Excavated a 5' x 5' x 4' deep hole. Went through 29" of asphalt and subbase before hitting clean sand. Found no stone. May have been lost to a storm sewer line. Measured north 76.00 feet to a found capped iron in a monument box (RLS 9734). The position of the Pavilion corner iron has been ratified by the Kalamazoo County Remonumentation Peer Group and is awaiting the placement of a Harrison Monument.

C. Description of monument for corner and accessories established to perpetuate locating the position of the corner:

A-8, West Quarter Post Section 19, Town 3 South, Range 9 West. Ratified by Kalamazoo County Remonumentation Peer Group on September 23, 1999. The position of the found ½" rebar is accepted as the best available evidence of the position of the original corner. Set a 20" Harrison Monument in a Monument Box in place of the ½" diameter rebar.

Set P.K. nail in power pole N 18 ° E 59.62'
Found P.K. nail in power pole N 65 ° E 49.07'
Found P.K. nail in power pole S 39 ° E 35.84'
Back of concrete walk West 33.77'
Southwest corner of house Northeast 67.03'

Intersection of concrete walk Northeast 42.00'
