A. Description of original monument and accessories and/or subsequent restoration;

Corner Post established by U S Government Deputy Surveyor John Mullett, 1825,

Accessories: Beech 6 S47W 24, Beech 5 N36W 26.

Survey by F. Hodgeman, 1869, Found about 3" of Original Stake from Stump of one witness. Set Slate Stone 18" long with point at surface and smaller Stone around. Accessories: Black Ash 15 S29E 73, Elm 15 S49 59.

Remonumentation by F. Hodgeman, 1883, Found Stake and Stone of former survey by myself and 2 bearing trees standing. Bored 3' in Stake Hole beside Stone, filled bottom with broken Brick and set 2' Earthen Post on top.

B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:

Original Corner and Accessories not recovered. Found Solid Clay Tile with X on top and Stone around 36" below road surface as called for in 1883 Remonumentation by F. Hodgeman.

Description of monument for corner and accessories established to perpetuate locating the position of the corner: M-9, Corner of Sections 24 & 25, T3S-R9W, Ratified by Kalamazoo County Remonumentation Program Peer Group on September 16, 1993. Found Solid Clay Tile with X on top and Stone around and is accepted as a careful and faithful perpetuation of the Original Corners position. Placed 20" Harrison Monument above Solid Clay Tile with X on top and placed Monument Box over Corner.
