Found rusted 3/8" iron in timber in swamp. Further digging revealed wooden stake 1.7' East of iron, top rotted off, old fence post rotted off was found to the North of wood stake. United States Government called for 80 lks. jog. F. Hodgman called for 80 lks. jog, it measured 52.34' from stake to tile set by F. Hodgman, County Surveyor. 3/8" iron is believed to have been used in survey for "Sugarloaf Acres Plat" by Gove recorded in L-22 , P-22 of plats.
