A. Description of original monument and accessories and/or subsequent restoration:

Corner Post established by U S Government Deputy Surveyor Robert Clark, 1826, Accessories: W Oak 14 N51E 18, W Oak 11 S48E 39.

Survey by Ed Strong, County Surveyor, 1875, Found Stone by Nutting, Accessories: W Oak 12 N about 50 E 66, W Oak 10 N54½ 49 or 99.

Survey by H C Fleming, 1915, Iron Stake, Accessories: Rail fence in line South,

14" Maple S W 27.3', 6" Maple N W 36.3'.
Survey by Ingersol, Watson & McMachen, 1979, Found Iron Rod, Accessories: 15"
Walnut N45W 36.81', P.P. N47E 48.04', P.P. S52E 59.80'. Top N E Cor Tel Ped Box #7600 S40W 32.86'.

B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:

Original Corner and Accessories not recovered. Stone by Nutting found by Ed Strong, 1875, and Accessories not recovered. Found Spike over ½" Iron, Accessories: P.P. S58E 59.80', Top N E Cor Tel Ped Box #7600, S14W 32.86'. Extensive digging (10'x10'x5') revealed nothing else.

C. Description of monument for corner and accessories established to perpetuate locating the position of the corner: F-7, S<sup>1</sup>/<sub>4</sub> Corner Section 16, T4S-R1OW, Ratified by Kalamazoo County Remonumentation Program Peer Group on September 16, 1993. Found Spike over ½" Iron called for in 1979 Survey by Ingersol, Watson & McMachen and is accepted as the best available evidence of the position of the original Corner. Removed Spike and 2" Iron. Placed 30" Harrison Monument in their place and placed Monument Box over Corner.
