September 25 do hereby certify that under requirements of P.A. 74, Michigan P.A. of 1970, the corner points mentioned in lines 1 and 2 above were in conformance with regulations and rules therefore as required in the current manual of survey instructions of the United States Department of the Interior, Bureau of Land Management or by a decree of a Court of Law and/or that the corner points mentioned in lines 3, 4 and 5 above were in conformance with the rules of the Michigan Board of Professional Surveyors or by a Decree of a Court of Law; established, re-established, monumented, re-monumented, recovered, found as expressed below:

A. Description of original monument and accessories and/or subsequent restoration:

1829 - E.H. Lytle, D.S., Set quarter Section post, Wh. Oak 18" N. 591/4° E. 18 lks., Wh. Oak 18" S. 11° W. 46 lks.. 1874 - F. Hodgman, Surveyor, "Found stone." (N.W. cor., W.1/4 cor., and S.W. cor. of Sec. 2 were on a straight line.)

1879 - F. Hodgman, C.S., "Stone of former survey correct."

1902 - Ed Strong, C.S., "Found stone, Hickory 8" S. 250 W. 127 lks., 1 U.S. stump in road.

1902 - Ed Strong, C.S., Found stone, hickory good, U.S. stump (measured from W1/4 corner North 2810.94 feet to N.W. corner).

B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:

Found iron rod in monument box, removed iron and box, dug and found very old iron drill shaft rusted into two pieces about 12" long, 0.2' West and 0.2' South of surface iron. Removed drill shaft and continued digging to a depth of 5 feet and found no further evidence of corner. Area around corner appears to have been cut ±2'-3'. Measured North 2808.35 feet to standard marker at N.W. corner and measured South 2660.72 feet to ratified position of S.W. corner.
