Description of corner evidence found and/or method applied in restoring or reestablishing corner:

A-8 & M-8 - 1/4 corner common to Section 19, T17N, R13W and Section 24, T17N, R14W, Lake Co., Mi.

I found Griffin's 5" Concrete Monument 4 feet more or less North of the centerline of East and West Blacktop road in Monument box (17" below surface). Condition of the accessories are as follows: #1 Gone, #2 Gone, #3 Gone, #4 Possibly #6, #5 Found (decaying) #6 Found in good condition, #7 Found stump, #8 Found in good condition, #9 Found in good condition, #10 Found in good condition, #11 Found stump, #12 Found in good condition.

Blass's accessory #6 could very well be Johnson's accessory #4, which would place the corner some 4 feet South of it's present location and in the center of road. I do not feel that I have sufficient evidence to move the corner and upset all the survey's that have been generated from it.

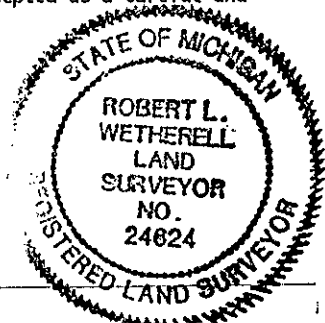

A-8 & M-8 - 1/4 corner common to Section 19, T17N, R13W and Section 24, T17N, R14W, Lake Co., Mi.

I placed a 3/4" re-bar the Lake County Brass Cap directly over the 5" Square Monument and is accepted as a careful and faithful re-establishment of the position of the original corner.
