B. Description of corner evidence found and/or method applied in restoring of reestablishing corner:

I found a 1" x 30" Pinch Pipe in centerline of road East and West and 5 feet more or less East of old fence line to South.

Condition of the accessories are as follows: #1 Gone, #2 Gone, #3 Gone, #4 Found in good condition (20"), #5 Found stump, #6 Found Stump, #7 Found in good condition, #8 Found in good condition.

C. Description of monument for corner and accessories established to perpetuate locating the position of the corner:

I replaced the 1" pipe with a 3/4" x 24" rebar with Lake County Remon Cap, and is accepted as a careful and faithful reestablishment of the position of the original corner.
