B. Description of corner evidence found and/or method applied in restoring of reestablishing corner:

I found a 1/2" capped iron in line with road to East and 10 feet East of centerline of road to North and 25 feet South of road to West. Road construction would have destroyed Hollister's stone so did not dig.

Condition of the accessories are as follows: #1 Gone, #2 Gone, #3 Found Stump, #4 Gone, #5 Found in good condition, #6 Found in good condition, #7 Found in good condition, #8 Found in good condition.

C. Description of monument for corner and accessories established to perpetuate locating the position of the corner: I replaced the 1/2" rod with a 3/4" x 24" rebar with Lake County Remon Cap, and is accepted as a careful and faithful reestablishment of the position of the original corner.
