B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:

A-4 & M-4 - 1/4 Corner common to Sec. 7, T19N R13W and Sec. 12, T19N, R14W, Lake Co., Mi.

I found U.S.F.S. Monument badly damaged by Lake County Road Commission road grader, (Lake County Road Commission informed me in 1994 that they had hit the monument). I reset the corner from found accessories No. 5, No. 6 and No. 7 above. Corner is 22 feet West of centerline of North and South road. Condition of the accessories are as follows: #1. Gone, #2. Gone, #3 Gone, #4 Found in good condition, #5. Found in good condition, #6. Found stump, #7. Dead.
