Sept. 24, 1996 I found iron pipe in monument box and witnessed it.

1996 Dean Gutekunst and Jackson Co. Rd. Comm. dug hole 6' +/- E-W by 8' +/- N-S but didn't find anything.

Description of corner evidence found and/or method applied in restoring or reestablishing corner:

May 19, 1997 Dean Gutekunst PS 18658 set a Harrison monument in a monument box in the base course of asphalt road.

May 28, 1997 I found Jackson Co. Harrison monument stamped PS 18658 in a monument box. July 9, 1997 Dean Gutekunst P.S. 18658 recorded this corner under the Jackson Co. remonumentation program in L 1546, P467, Jackson County Records.
