GLO 1824, John Mack, set 1/4 Sec. post W. Oak 6 N 9 E 20, W. Oak 4 S 16 E 50 July 1828, Anthony McKey, Surveyor started at this conrer and surveyed the road to the North. Jan. 1919, D. Gibbs & W.E. Frazier "drove gas pipe and bricks" and surveyed the road to the North. May 1927, Fred W. Soll, M.S.H.D. did a survey for the Girls Training School and "put iron pipe through the macadam pavement".

1948 to 1965, Four recorded plats and one condominium are tied to this comer as well as numerous surveys. July 1974, I found iron pipe 4" below surface of the pavement and recorded it in L. 2, P. 647 Oct. 1977, Arvin Butterfield, found 3/4" iron pipe in monument box and recorded it in L.2, P. 647.

May 1990, I found the iron pipe in monument box and recorded it in L. 4, P. 20.

B. Description of corner evidence found and/or method applied in restoring or reestablishing corner:

August 12, 1996, Found 1" X 24" iron pipe in monument box under new pavement. Removed the iron pipe and the monment box. Dug deeper but didn't find anything else. The corner is in a cut of the original ground. The plat monument that was 33' East has been removed. I re-set a 3/4" X 3' gas pipe in the same location as the found 1" iron pipe and re-set the monument box in the new pavement raised 1 1/2" to be flush with the final course of asphalt.

C. Description of monument for corner and accessories established to perpetuate locating the position of the corner:

3/4" X 3' gas pipe capped G.E.R. 13040 in monument box and is accepted as the best available evidence of the position of the original corner.
