Richard in a field survey on September 8. do hereby certify that under requirements of P.A. 74, Michigan P.A. of 1970, the corner points mentioned in lines 1 and 2 above were in conformance with regulations and rules therefore as required in the current manual of survey instructions of the United States Department of the Interior, Bureau of Land Management or by a decree of a Court of Law and/or that the corner points mentioned in lines 3, 4 and 5 above were in conformance with the rules of the Michigan Board of Land Surveyors or by a Decree of a Court of Law; established, re-established, monumented, re-monumented, recovered, found as expressed below:

Description of original monument and accessories and/or subsequent restoration:

GLO 1824 Ziba Swan set 1/4 Sec. post Beech 30 N 80 E 15 Beech 7 N 75 W 20

1873 James Blair "Found 1/4 post & put down stone"

1877 James Blair called for "stone"

1947 Walter Frazier found stone at surface with stones & bricks around the stone.

Set iron pipes 33' East & West. End post E. 25.5

1965 Kenneth Suydam dug but all traces of the corner was gone. He used a point determined from the iron pipe 33' west and end post E. 25.5 to do a survey in Section 33 north of the railroad.

1987 Kenneth Suydam retraced his 1965 survey and set a iron pipe in the pavement (all witnesses being gone)

1988 I found the iron pipe and recorded it in Liber 5, Page 199

Description of corner evidence found and/or method applied in restoring or reestablishing corner:

September 8, 1999 Found the iron pipe in the pavement which checked the witnesses. Land owner whose house is part of my witnesses told me the road was cut down in 1948 during re-construction which explains why Kenneth Suydam found no trace of the monumentation in 1965. I replaced the iron pipe with a 5/8" X 3' re-rod with Lenawee County re-mon cap stamped P.S. 13040. Set monument box in base course of new asphalt.

C. Description of monument for corner and accessories established to perpetuate locating the position of the corner:

5/8" X 3' re-rod with Lenawee County Re-mon cap stamped P.S. 13040 in monument box and is accepted as a careful and faithful perpetuation of the position of the original corner.
