1891 James Blair reestablished the corner "Set stake in Drain 32 1/2 lks east of fence post

1928 Harold Clegg surveyed Thompson Hwy, and called out "West 1/4 post Section 18, Riga (could not find) station 24+77.1 and east 1/4 line Section 13 station 25+95." Difference=117.9

1971 I set 1" X 4' iron pipe on east bank in line with fence west and at record distance east from iron sleigh runner found at the center of Section 13

1980 I found 1" galv. pipe on east ditch bank 10± west of west edge of pavement and recorded it in L 4 P 330.

Description of corner evidence found and/or method applied in restoring or reestablishing corner:

April 10, 1998 Found 1" galv. pipe on east slope of deep ditch about 2' above the water. Drove it down 12" put GER PS 13040 cap in top. I left the galv. pipe instead of replacing it with a Harrison monument as I think it is more stable than a Harrison monument because of the location.

Description of monument for corner and accessories established to perpetuate locating the position of the corner: C.

1" X 4' galvanized pipe capped G.E.R. P.S. 13040 and is accepted as the best available evidence of the position of the original corner.
