## (M-10) 1/4 Corner Common to Section 25, T. 45 N., R. 11 W. and Section 30, T. 45 N., R. 10 W This corner is being perpetuated as part of the Luce County Remonumentation Program.

Found a 1" pipe with a 4" aluminum DNR cap stamped 1992 at the position recorded by Buckler in 1967. The position as monumented falls 3.23' West and 0.70' South of a single proportionate position between the section corner 1/2 mile North and the township corner 1 1/2 miles South. Could find no trace of the original corner or other contrary evidence and accepted the corner as found.
